DxF Updates

DSA SIGNATORY GRANTS:

- DSA Signatory Grantee Progress Reports with Milestone achievements submitted by the March 31, 2025 deadline are under review. If approved for payment, disbursement will occur by April 30, 2024.

TECHNICAL ADVISORY SUBCOMMITTEE (TASC) SOCIAL DATA EXCHANGE:

- CDII held the second meeting of the 2025 Technical Advisory Subcommittee (TASC) Social Data Exchange focus group on Thursday, April 10, 2025. Participants began discussing a proposed reference architecture for exchanging health and social data using DxF.
