



# DxF Bi-Weekly Update

*The Center for Data Insights and Innovation (CDII) is providing this bi-weekly communication to provide important updates and information on the Data Exchange Framework (DxF).*

## DxF Updates

- **As a reminder**, CDII has published the final [Data Exchange Framework \(DxF\) Roadmap](#) to the CDII DxF webpage.
  - The DxF Roadmap describes how the state and stakeholders can work together through 2027 to collectively invest in data exchange efforts that advance whole person care, leveraging efforts across the health and human service ecosystems, inside and outside of government.
  - Stakeholders are encouraged to review and share the Roadmap within their networks to assess opportunities to support and align to data exchange priorities in California.
- CDII has added a new answer to the [Data Exchange Framework FAQ](#).
  - This answers if health plans and insurers are required to share adjudicated claims, encounter date, and clinical elements in the USCDI with all DxF Participants, or only with Individuals through Individual Access Services.
