The Center for Data Insights and Innovation (CDII) is providing this bi-weekly communication to provide important updates and information on the Data Exchange Framework (DxF).

DxF Updates

- A key goal in CDII's DxF three-year roadmap is to establish a statewide structure for communicating significant events to all authorized DxF Participants that request them. To explore this goal, CDII has posted a Request for Information (RFI) about a roster service. This would allow DxF Participants to request notifications and identify where to direct notifications. **If you are interested, please respond to [the RFI](#) or share with others in your network who may be interested.**

- All Round 1 and Round 2 Grantees (those that applied between May 16, 2023, and September 1, 2023) **must complete Milestone 1 by December 31, 2024.**

PARTICIPANT DIRECTORY:

- **Did you know** that over 45% of DxF Participants have indicated their methods of exchange in the Participant Directory? They have done so by either indicating how they have chosen to share health and social services information or that they have elected to delay exchange until January 31, 2026 (for those eligible to do so). Of Participants entering a choice, approximately 80% of physician organizations and medical groups, 45% of hospitals, and 50% of plans have chosen to use a QHIO.
