DxF Updates

DSA SIGNATORY GRANTS:

- The progress report deadline for submission by September 30, 2024 has passed. All QHIO Onboarding grants wherein the grantee has selected a QHIO were submitted timely - thank you to all of the QHIOs involved!
- ALERT: If you are a Technical Assistance grantee or a QHIO Onboarding grantee who has not selected a QHIO yet, look for an email from CDII's third party administrator (TPA) PCG about submitting your delinquent progress report immediately.

- In its meeting on Friday, September 27, 2024, the Standards Committee recommended that CDII advance requirements in the Data Elements to Be Exchange P&P to include US Core Data for Interoperability (USCDI) version 3 by January 1, 2026, to align with federal requirements for health care providers.
