DxF Updates

DSA SIGNATORY GRANTS:

- All Grantees are required to submit a quarterly progress report by the end of day September 30, 2024. QHIOs will submit on your behalf if you are a QHIO Onboarding Grantee. If you are a Technical Assistance (TA) Grantee, login to [PCG's DxF Grants Portal](#), navigate to your Progress Report, and select one of the following:
 - If you have not yet met Milestone 1:
 - Providing status only; not ready to demonstrate Milestone 1
 - Ready to demonstrate Milestone 1
 - If you have already submitted a progress report for Milestone 1:
 - Under the Milestone 1 section, select "Already achieved Milestone 1, ready to report on Milestone 2; and
 - Select either "Providing status report, not yet ready to demonstrate Milestone 2" or "Ready to demonstrate Milestone 2"
