## DxF Updates

- New DxF FAQs available: Read the updated FAQs [on the DxF website](#)
  - HCAI has revised the DxF Frequently Asked Questions (FAQs) to provide additional information in accordance with Senate Bill 660. The updated FAQs are now available on the DxF website, and include new information related to DSA signatory definitions.
  - Highlighted sections within the FAQs identify definitions that were introduced or clarified by Senate Bill 660, including:

- Physician Organizations and Medical Groups (POMGs) that are required to sign the DSA,
  - Entities encouraged but not required to sign,
  - Emergency Medical Services (EMS) entities that are required to sign,
  - Exchange deadlines for state hospitals,
  - Signing as a condition of contracting,
  - Emergency Medical Services Authority (EMSA) planned support for EMS entities.
- Reminder: DxF Accountability Measures
    - The Administration and the Legislature determined that additional accountability structures would be beneficial to strengthen long-term compliance.
    - These provisions are intended to promote consistent compliance while enabling the Legislature to consider further action, if warranted, based on advisory committee recommendations and ongoing implementation experience.

- The Data Exchange Framework Program has created a [Participant Verification Standard Operating Procedure](#) to verify new DSA Signatories and DxF Participants. This process will help ensure that DxF Participants are legitimate health or social services organizations, governmental agencies, or vendors that provide services to those entities and have a legitimate need to receive health and social services information.
- Organizations that have had their DSA terminated or voided and access to HSSI under the DSA revoked can be found on the Unverified Participant List published on the [DxF website](#).
